ORDER:

In the Government order third read above a draft notification was issued to amend rules 172 and 343 (a) of the Tamil Nadu Motor Vehicles Rules, 1989 regarding display of advertisements on stage carriages. Objections and suggestions were invited from the public to the said draft amendment. The draft amendment has been published as Home Department Notification No. SRO A-14/2010, in page 24 of Part III-Section 1(a) of the Tamil Nadu Government Gazette dated 28th April 2010.

2. Certain representations have been received from public making certain objections and suggestions to the draft amendment. The Government have decided to overrule the objections / suggestions except one suggestion relating to deletion of the word 'major' proposed in the draft amendment and decided to confirm the draft amendment after deleting the word 'major' as issued in the said G.O.Ms.No.364, dated 9-4-2010 and published in the Tamil Nadu Government Gazette No.16, dated 28-4-2010.

3. Accordingly, the following notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION.

In exercise of the powers conferred by section 96 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), the Governor of Tamil Nadu, hereby makes following amendments to the Tamil Nadu Motor Vehicles Rules, 1989, the draft of the, same having been previously published as -required by sub-section (1) of section 212 of the said Act.

AMENDMENTS.

In the said Rules :-

(1) in rule 172, after sub-rule (10), the following sub-rule shall be added, namely:-

"(11) It shall be a condition of permit of every transport vehicle that the vehicle shall not carry or display advertisements in contravention of rule 343." and

(2) in rule 343, in sub-rule (a), for the third proviso, the following provisos shall be substituted, namely:-

"Provided also that in the case of stage carriage, no advertisement shall be carried or displayed on the front wind screen or rear window or side windows of the vehicle and if there are glass panels above the windows on the sides of the vehicle, advertisements may be displayed on such panels:

Provided also that the advertisements shall not be offensive, obscene or cause for distraction to the road users."
