A copy of the Government Order received in the reference cited is en closed.

The Government have exempted the rig mounted vehicles from the provisions of Rule 93(2) (i) of Central Motor Vehicles Rules 1989 in respect of Overall length of the vehicles subject to fulfillment of any or all the conditions specified in the overall dimension of motor vehicles.

Hence all the registering authorities in Tamil Nadu are hereby instructed to register the rig mounted vehicles which need exemption under Rule 93(2) (i) of Central Motor Vehicles Rules, 1989 by collecting the fee prescribed under Rule 366 of Tamil Nadu Motor Vehicles Rule, 1989 towards the exemption for each vehicle for having excess length.

ORDER:-

The Transport Commissioner has sent proposal seeking exemption In respect of overall length of the rig mounted vehicles from the provisions of rule 93 (2) (i) of Central Motor Vehicles Rules, 1989 for the reasons stated in his letter read above.

The Government examined the proposal in detail and accepted the proposal of the Transport Commissioner. Accordingly, under section 110 (3) (b) of Motor Vehicles Act, 1988 (Central Act 59 of 1988), the Government exempt the rig mounted vehicles from the provisions of rule 93 (2) (i) of Central Motor Vehicles Rules, 1989 in respect overall length of the vehicles subject to fulfillment of any or all the conditions specified / in the Overall Dimension of Motor Vehicles (Prescription of conditions for exemption) (Rules, 1991, which the Transport Commissioner may deem fit to impose and subject to,' collection of fee prescribed under rule 366 of Tamil Nadu Motor Vehicles Rules, 1989 \ towards the exemption for each vehicle for having excess length.
