ORDER:

According to Section 40 of Motor Vehicles Act.. 1988, every owner of a motor vehicle shall cause the vehicle to be registered by a registering authority in whose jurisdiction he has the residence or place of business where the vehicle is normally kept. Normally, when a vehicle is purchased by a person, the Vehicle will be registered by the registering authority in whose jurisdiction he has the residence based on the address proof contained in the sale invoice of tile vehicle. The Director General of Police, Chennai has stated that he has purchased some vehicles in his name (as per sale invoice) in Chennai and allotted to various other offices of Police Department for use. In this connection, when requests received to allot fancy registration numbers to those vehicle in the concerned district, a question has arisen as to Whether the vehicles purchased by the Head of department under the jurisdiction of a Regional Transport Officer/Registering Authority may be permitted to be registered by another Regional Transport Officer/ Registering Authority of the vehicle is allotted to other office of that department with whom the vehicle will be kept for use.

2) After careful consideration, the Government consider that the vehicle purchased by Government Department in one jurisdiction of Regional Transport Officer/Registering Authority Chennai may be permitted to be registered by another Regional Transport Officer / Registering Authority if the said vehicle is allotted to other office of the that department, with whom the vehicle is to be kept for use under the jurisdiction or the another Regional Transport Officer/Registering Authority. Accordingly, the Government direct that the vehicle purchased in the name of Head of Department in the jurisdiction' of Regional Transport Office / Registering Authority, Chennai for departmental use be permitted to be registered in the Jurisdiction of another Regional Transport Officer/Registering Authority where the vehicle allotted to other office of the that department with whom the vehicle Is to be kept for use under the jurisdiction of the another Regional Transport Officer/Registering Authority. . .
